

# Terms of Service

*Last Updated: February 6, 2026*

## 1. Acceptance of Terms

By accessing or subscribing to any creator membership platform operated by Global Node Management ("the Service"), you agree to be bound by these Terms of Service. If you do not agree to these terms, you may not access or use the Service.

## 2. Eligibility

You must be at least 18 years of age to subscribe to or access this Service. By subscribing, you represent and warrant that you are at least 18 years old and have the legal capacity to enter into this agreement.

## 5. Cancellation and Refunds

### Cancellation

You may cancel your subscription at any time from your account settings. Cancellations take effect at the end of your current billing period. You will retain access to the Service until that date.

### No Refunds

**All subscription fees are non-refundable.** Due to the digital nature of the content and immediate access provided upon subscription, we do not offer refunds for any reason, including:

- Partial billing periods
- Unused time

- Changes in personal circumstances
